### PLEASE READ CAREFULLY

By enrolling in this program, you agree to the following terms and conditions that govern the Honeywell Scan to Earn Rewards 2021 Program.

#### 1. Overview

Honeywell Middle East FZE ("Honeywell") offers this Honeywell Scan to Earn Rewards 2021 Program Season 21 ("Program") to contractors and trader partners in Bahrain, Jordan, Kuwait, Oman, Pakistan, Qatar, Saudi Arabia and UAE ("Participant(s)") which scan Honeywell Genetron R134a, Genetron R410A, Genetron 404A, Genetron 407C and Solstice EZ Flush products ("Product(s)") using the Genetron Mobile Application (the "App") to earn points ("Point(s)") that will be credited to Participant(s) account, and may be redeemed for select rewards.

#### 2. Eligibility and Participation

a) The Program is only open to contractors and trade partners established under the laws of the above mentioned countries. It is void where prohibited by law. Participant(s) must have a valid account on the App. For the avoidance of doubt, this Program is not open to wholesalers, traders, distributors, resellers or anyone not consuming the product and therefore Honeywell reserves the right to verify the identity of Participant as a contractor and approve individual companies participation in the Program before redeeming awards. b) Continued participation in the Program constitutes each Participant's continued full and unconditional agreement to these Program Terms and Conditions, as they may be updated from time to time ("Rules"), and representation that Participant meets the eligibility requirements set out in these Rules. Those who do not comply with these Rules may be prohibited from participating in the Program as determined by Honeywell in its sole discretion.

#### 3. Term, Modification and Termination

This Program shall be in effect from 20th June 2021 until 31st December 2021 ("Term"). Honeywell also reserves the right to suspend or modify the Program, at its discretion, at any time with or without notice. Termination, modification or suspension may affect a Participant's ability to redeem accumulated Points.

#### 4. Scope of Program

a) Participant is (i) a contractor who in the ordinary course of business purchases Product(s) through Honeywell's authorized channel partners ("Honeywell Authorized Distributors"), and provides maintenance, service, repairs and other technical services on Refrigeration and Air Conditioning systems and equipment, and uses it to charge his own or his customer's HVAC system, or (ii) a trade partner who in the ordinary course of business purchases Product(s) for resale to any other trade partner or contractor. b) When Participant purchases Product(s) and scans same using App Points shall be awarded and credited to Participant(s) account. c) 1 Original Scan (as defined below) is equal to 1 reward points, or as determined by Honeywell in accordance with any applicable additional reward program as described in section 4.e below.

d) Product(s) may only be scanned once, and only the original scan may be eligible for Point(s) ("Original Scan"). Honeywell does not accept any liability in the event that another party has previously scanned Product(s). e) Honeywell may from time to time, at its sole discretion, offer additional reward programs in specific territories for a defined period of time.

#### 5. Redeeming Points

a) Points may be redeemed as follows for Honeywell products ("Reward(s)"): 

- 200 points = Bronze Rewards = Any 1 HFC Refrigerant Jug
- 400 points = Silver Rewards = Any 2 HFC Refrigerant Jugs
- 700 points = Gold Rewards = Any 4 HFC Refrigerant Jugs
- 1000 points = Platinum Rewards = Any 7 HFC Refrigerant Jugs

 b) Any Points earned by Participant in excess of 1000 may also be eligible for rewards, however Participant may elect how to redeem the volume subject to any combination of the Tiers above; e.g. if Participant has 1400 points they may elect either: 

- i. 7 x Bronze = 7 Jugs + 0 points balance;
- ii. 1 x Gold + 1 x Silver + 1 x Bronze = 7 jugs + 100 reward points balance;
- iii. 2 x Gold rewards = 8 jugs with 0 points balance; or
- iv. 1 x platinum + 1 x silver = 9 jugs with 0 balance points.

 c) Honeywell reserves the right to modify the list of items available for Rewards, as well as their corresponding Point values, at any time for any reason. d) Reward(s) shall be processed and delivered by Honeywell Authorized Distributors in the event of any product issue arising out of delivered Reward(s) then the dispute shall be settled between Honeywell Authorized Distributors and Participant(s). e) Participant(s) may carry over unredeemed points in the event that Honeywell elects to extend or modify the Program, however in the event of a modified program Points shall be redeemed subject to the terms and conditions of said modified program. In the event that Honeywell elects not to extend or modify the Program, any points redeemed after 1 month of the expiration of the Program (i.e. February 1st, 2022) not be accepted and shall be considered forfeited by Participant. f) Points do not constitute property, do not entitle a member to a vested right or interest and have no cash value. As such, Points are not redeemable for cash, transferable or assignable for any reason. Any Points remaining in Participant(s) account if the Program is canceled will be forfeited without compensation. In addition to suspension or discontinuance of the Program eligibility, Honeywell shall have the right to take appropriate administrative and/or legal action, including criminal prosecution, as it deems necessary in its sole discretion. b) Any disputes regarding eligibility for the Program, the availability of items, or a Participant(s) compliance with these Rules will be resolved by Honeywell in its sole discretion. c) Honeywell is not responsible for any incorrect or inaccurate information supplied by Participant(s) while participating in the Program. d) The Program is subject to all applicable laws and regulations, and will be governed by the laws of the Dubai International Financial Centre, and any disputes shall be resolved by the Courts of the Dubai International Financial Centre. If any provision of these Rules is found to be invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed from the remainder of these Rules, which will otherwise remain in full force and effect. Honeywell's waiver of any breach, or failure to enforce any of the terms and conditions of this Program, at any time, will not in any way affect, limit or waive Honeywell's right thereafter to enforce and compel strict compliance with every term and condition hereof.
